Year 6 Street Maintenance

The City Engineer is designing a bid package for Year 6 Street Maintenance. We expect to bid this project in January/February of 2023.

Huebner Elevated Storage Tank

The bid opening for the Huebner Elevated Storage Tank was approved by City Council on November 15th. This is the last elevated tank that needs to be rehabilitated and repainted. The project will start in January.

Code Amendments

Staff is working with the City Attorney to revise the Sustainability Overlay District regulations pertaining to building construction materials, color, and style to ensure we comply with state law. Once this is complete, we will take this back to the City Council for an amendment to the Code and consider uses allowed in the B-3 zoning district with Sustainability Overlay zoning, with or without a Specific Use Permit. Once this is reviewed and revised, we will construct a timetable for completion.

PUBLIC WORKS

- Staff is working on creating a school crossing zone on Huebner Road, from just north of Redbird to just before Chapparal. The zone would encroach into the City of San Antonio, so we would need their permission to install signage and slow the traffic to 20 mph.
- Staff has contacted Bexar County Public Works about piggybacking off of their contracts for street maintenance and other work projects. Staff will be bringing an Interlocal Agreement to City Council for their consideration.
- Staff submitted a grant request for funding of the creation of a transportation plan to support the Safe Streets for all initiatives.
- Staff and the City Engineer are working on the Huebner Creek Hike & Bike Trail Segment II.
- Working on an application for TxDOT funding of another segment of trail, from Evers Road, through Huebner Creek, up to the city limits.
- Replacing sections of sidewalk on Forest Brook and Stable.
- Replacing signage city-wide.
- Making repairs to the merry-go-round.

• Cleaning and videotaping the sewer lines on Forest Ridge, Forest Way and Forest Brook.

FIRE DEPARTMENT

- The Fire Department will be out and about on our Santa Runs. The Santa runs go through the neighborhoods and will go from Sunday, December 18th through Thursday, December 22nd. Please check the website for when your area will receive a visit from Santa on the fire truck.
- Dr. Sparkman came by and reviewed all November run forms and critiqued them with the on-duty crews.
- The fire department completed a total of 359 hours of fire and EMS training in November.
- The Fire Department is working with the permitting office and the LV Historical Society to review plans and requirements to gain a certificate of occupancy for the Huebner-Onion House. An on-site inspection is scheduled for early January.
