Community Center Remodel

Project has been completed.

Seneca West Drainage Project

Engineering and design work continues on the Seneca West Drainage Project. The proposed alignment will be sent to the San Antonio River Authority (SARA) and the Corp of Engineers for their approval. The Texas Historical Commission has mandated that we obtain a Texas Antiquities Permit and perform archeological work in this area.

The 95% plans have been submitted to Bexar County for their review. Once completed, they will be sent to the San Antonio River Authority (SARA) for review and to request a Conditional Letter of Map Revision (CLOMR). The dates for the project bid may change, depending on how long it takes SARA to review the plans.

The Year 4 Street Maintenance Project

This project includes portions of Forest Mill, Stirrup, High Stepper, Whithers, Crownpiece, Trace Buckle, and Horsewhip. We will also be replacing water and sewer mains in this area. Bids were opened on June 2nd and the City Engineer is reviewing, then will make a recommendation. The Council postpone the first read on July 7, 2021. The item will go before City Council on July 20th. Once approved, we will meet with the contractor to determine the Notice to Proceed and get a project schedule. Due to Council tabling this item on July 6, 2021 the council BID award was moved from July 20, 2021 to August 3, 2021.

- Constructing a basketball court at The Ridge at Leon Valley Park. The first section has been poured. Forming on the second half has been delayed due to rain and flood cleanup. This project will resume on Monday, August 9, 2021.
- Crew began repairing a cul de sac on Wagon Spoke, with an asphalt repair.
- Crew completed a repair on a section near the Huebner Rd. bridge, and poured with concrete. The damage was caused by scouring due to the recent flooding.

- Crew completed the sewer main replacement behind Stirrup Lane.
- Finalizing Lead and Copper sampling with the TCEQ, and preparing to deliver sample bottles, and instructions to residents on the sampling plan. We plan to begin handing out bottles next week. The samples are due September 1, 2021.
- City Secretary's Office certified a "petition" that was submitted by Cindy Henley on July 19, 2021 in regards to the Hike & Bike Trail. The "petition" was declared "DEFECTIVE". Ms. Henley was notified the same day.
- The fire department perimeter fencing is being installed. This was not previously installed due to the LC-17 project.
- The Fire Department hosted an Advanced Cardiac Life Support training class for a small group of University Health System nurses.
- MIH is currently developing a fall prevention program with the cooperation of STRAC to meet the needs of our residents.
- Barring any unforeseen delays Cha Cha's Café New Gen is scheduled for a softopening Monday, August 2nd, 2021.
- TML Risk Adjusters are scheduled to be here on the week of August 9th to assess damages to City facilities associated with the July 6 flood.
