#### Seneca West Drainage Project

Engineering and design work continues on the Seneca West Drainage Project. The proposed alignment will be sent to the San Antonio River Authority (SARA) and the Corp of Engineers for their approval. The Texas Historical Commission has mandated that we obtain a Texas Antiquities Permit and perform archeological work in this area.

The 95% plans have been submitted to Bexar County for their review. Once completed, they will be sent to the San Antonio River Authority (SARA) for review and to request a Conditional Letter of Map Revision (CLOMR). The dates for the project bid may change, depending on how long it takes SARA to review the plans.

#### The Year 4 Street Maintenance Project

This project includes portions of Forest Mill, Stirrup, High Stepper, Whithers, Crownpiece, Trace Buckle, and Horsewhip. We will also be replacing water and sewer mains in this area. Bids were opened on June 2 and the City Engineer is reviewing, they will make a recommendation. The Council postpone the first read on July 7, 2021. The item will go before City Council on July 20. Once approved, we will meet with the contractor to determine the Notice to Proceed and get a project schedule. Due to Council tabling this item on July 6, 2021, the council BID award was moved from July 20, 2021, to August 3, 2021. Council once again tabled this item and the date changed from August 3, 2021, to August 17, 2021

#### OTHER

- Constructing a basketball court at The Ridge at Leon Valley Park. The first section has been poured. Forming on the second half has been delayed due to rain and flood cleanup. This project should be completed on August 20, 2021.
- The Crew is repairing walking trail in Raymond Rimkus Park.
- The Crew repaired potholes on Poss Road.
- The Crew will be removing old flood damaged fall zone materials and replacing with new materials at both playgrounds in Raymond Rimkus Park.
- The Crew will be mowing the Huebner-Onion Homestead, Wurzbach Road easements, The Ridge at Leon Valley Park, and Samaritan Road property this week.
- The water Crew will be running a sewer camera at 6811 Bandera Road to see if the sewer lateral is broken.
- The City Secretary's Office completed the cost comparison of various providers for services such as agenda and minutes, website design, permit software, and codification. Held a Zoom meeting for directors and city managers to hear presentations from Municode, JustFOIA, and MyGov. A spreadsheet with cost comparisons was provided to city managers for review.
- The Fire Department along with the Special Events Coordinator are conducting a backto-school supply drive. Donations will be accepted from August 2 through August 20. School items can be dropped of at City Hall or the Library. Look for the large yellow trash cans located in front of the facility.
- The Fire Department has ordered additional Single Use Disposal System (pill mail in disposal bags) for additional locations in the city. There is currently one location at the Fire Department and it can be accessed 24 hours a day 7 days a week. City, Community Center, and the Library will have this system installed.
- The Fire Department received a spot inspection from the Department of Health and Human Services concern our EMS services and medical supplies. After the inspection was completed, we received a 100% passing score with no deficiencies noted.
- The Fire Department is currently enforcing a hazardous condition located at 5650 Grissom Rd, the Finley Apartments. The emergency escape access for multiple buildings has been deemed unsafe by a third part engineer. The Fire Department is working with the property owner to mitigate the current condition.
- The Fire Department is currently attempting to enforce fire code violations at 2 apartment complexes 6300 Rue Marilyne and 5622 Evers Rd. These complexes have created potentially unsafe environments due to the lack of maintenance to their properties.
- The Fire Department is now using a digital reporting application (Pulsara) to contact local Hospitals prior to EMS arrival. This application will give hospitals advanced notice of what type of patient is being brought to the hospital.
- MIH recently attended a STRAC Fall Workshop. This class will allow the MIH to identify fall hazards. It is his intention to put on classes for retirement centers.

• MIH attended a monthly meeting with other local jurisdiction's MIH's to get an update on all participating agency's progress with their MIH programs.
