#### **Public Works**

- Projects:
  - The contractor for the LC-17 project has been delayed by rain for the past week, but hopes to restart work this week. The project's projected end date is now August, due to the recent rains, with 30 days allotted for punch-list completion.
  - O Bids for the following projects were opened on July 2, 2019. After review and approval, they will be sent to the City Council.
    - 2019-05 Blacksmith Lane & Wagon Spoke Sewer/Water Main Replacement
    - 2019-06 Evers at Seneca Sidewalk Extension
    - 2019-07 Forest Meadow Drainage Improvements Raymond Rimkus Park
    - 2019-08 Leon Valley Street Maintenance Year 2
  - The City Engineer has finalized the documents for the Grass Hill well plant generator. The bids were opened on June 11th and will now go to Council for approval on July 9th.
  - o The City Engineer is finalizing the Huebner at Balky crosswalk bid documents. The bids will be ready to advertise this week.
  - Staff continues to meet with Waterworth software technicians to review water and sewer needs
    for capital planning purposes. We are in the process of creating an Infrastructure Capital Plan for
    the water and sewer system to be used for the next 20 years.
  - Staff is working on designs for the custom art proposed for the bus shelters at the library and the park.
  - Staff is working with CPS Energy and ChargePoint on a proposal to install electric vehicle charging stations at certain areas in the city. We expect to bring this idea to Council in August.

- Staff is working on the procedures for citizens to apply for the new rain barrel and xeriscaping rebate program. The program will give a \$40 water bill credit to people who install rain barrels at their residences and \$100 credit for people who install at least 200 square feet of xeriscaping, replacing the grass. The Plumbing Code is being revised to exempt rain barrels that are not connected to the City's water supply and are less than 400 gallons.
- O Year 1 Street Maintenance Project is almost complete. The contractor and staff will perform a final walk through this week.
- Staff is working on a cost sharing project with Bexar County to replace a portion of the water main, and then mill and overlay El Verde Road, once the LC-17 construction has been completed.
- Preparing to enhance the crosswalk on Evers in front of the library. Thermoplastic signs will be
  placed in the street in both directions, rumble strips will be installed, and signage will be placed
  farther away from the crosswalk.
- O Shade structures for the large playground at Raymond Rimkus Park were delayed by the contractor, but have finally arrived. They are being stored at Public Works until the contractor can perform the work to install them this work will be performed after the 4th of July event at the park.
- The pool contractor is working out a schedule for water aerobics at the Forest Oaks pool. There
  will not be an instructor, but the citizens that wanted the class will self-instruct. We'll report out
  once we know what days and times.
- o Constructing walking path at The Ridge at Leon Valley Park.
- o Assisting with the 4th of July event in clearing out the drainage structures in and around the park.
- Continuing to cleaning out tributary between William Rancher and Samaritan roads, weather permitting.
- o Continuing construction on pavilion at The Ridge at Leon Valley Park.
- o Installing/replacing signs city-wide.
- o Repairing sewer main on Rue Liliane.
- o Creating water and sewer main replacement plan.

We appreciate the local American Legion Department of Texas 20th District, Walter Geraghty Commander Gold Brigade hosting this event with The Leon Valley Fire Department. Thank you to Cub Scout Pack 485 and the Webelos Scouts for assisting to retire the American Flags with Dignity, Honor and Respect. The flag ceremony is comprised of Unserviceable flags that have flown with honor and require to be honorably retired from life. The Ceremony for Disposal of Unserviceable Flags in the traditional triangular fold, the Cub Scout Pack 485 and the Webelos Scouts unfolded and placed flags in fire pit to completely burn to ashes with reverence and dignity, as the flag burns everyone shows their respect by saluting to the flag with public words of respectful and honorable rites. Please note going forward unserviceable flags will be accepted by the Veterans of Foreign Wars (VFW) and flags may be recycled through recycle companies. - National Fire Protection Association Conference & Expo (training) Captain Eric Burnside attended the National Fire Protection Association (NFPA) Conference & Expo June 17-20, 2019 at Henry B. Gonzalez Convention Center. The NFPA Conference & Expo is the essential event for fire, electrical, and life safety professionals. It's an opportunity to learn more about the latest challenges around the world and the cutting-edge solutions to deal with them. Burnside had to opportunity to hear dozens of world-class speakers, visit with hundreds of exhibitors, share expertise with others, and connect with global network of colleagues all under one roof.
- **Fire Recovery USA Cost Recovery** The Fire department has received an incident recovery total collection in the amount of \$38,581.66 to date with 45 active runs, and 4 denials by insurance companies.
- Ladder Training at John Marshall High School (training) The Leon Valley Fire Department proactively prepares for emergency life threatening situations. Ground ladders may be cumbersome so training is crucial towards efficiency of ladder utilization. Ground ladders are often used to extend to roofs to ventilate by cutting a hole in the top of the roof this releases the smoke and gases escape because heat and smoke rise. It makes it much easier for the firefighters in the building to see. It also reduces the possibilities of backdraft and flashover (high-voltage electric circuit made through the air between exposed conductors). There are 3 different sizes of ladders 10, 24, 36 feet that are utilized for different situations and Firefighters check ladders for any safety concerns towards operations. Therefore, various scenario ladder training is vital in a real-life situation by selecting the correct ladder.
- Marshall Law and Medical Services Magnet School First Annual Freshman Symposium (community service) Marshall Law and Medical Services Magnet School is hosted their First Annual Freshman Symposium on Tuesday, June 25th from 8:30 a.m. 11:30 a.m. They welcomed students to the campus and gave them an opportunity to meet their new classmates and participate in some fun team building activities. The Leon Valley Fire Department and Leon Valley Fire Police Department participated with emergency vehicles as well as Firefighter/Paramedics engaged with students.
- **Fire Station Education Tour (community service)** Monday, June 17<sup>th</sup>, we had the pleasure of presenting a fire station tour to 30 kids and 20 adults. This provides a unique opportunity for the youth to meet firefighters and learn about what they do through a hands-on learning experience. The tour

included a presentation of the fire station, trucks including viewing a fire engine, ambulance, firefighting equipment, fire gear, emergency medical equipment and living quarters, as well as a short presentation concerning fire safety.

- **NISD EMS Committee (community service)** -The Leon Valley Fire Department has become a member of the NISD EMS committee. We will be working with NISD to develop their current EMS program and provide a resource to their students.
- Leon Valley Historical Society (community service) The Leon Valley Fire Department hosted the successful Leon Valley Historical Society- Pioneer Firecracker 5K Fun Run/Walk Packet Pick Up from 10am- 4pm in our training room.
