Public Works

- Projects:
 - The LC-17 crew is waiting for the creek to dry up before continuing. They will be working in the creek and on punchlist items.
 - Leon Valley Street Maintenance Year 2 we will be performing a walk through this week and preparing a punchlist for corrections.
 - Staff is still waiting on approval from VIA for the library and park bus shelter artwork. Once received, it is to be installed.
 - City Crews have started the concrete project on El Verde Road in front of the fire station. Work is expected to take 6 8 weeks, depending on weather and concrete curing times.
 - Staff will be forwarding some documents to Directors from CPS Energy and ClearResult to identify ways the City can reduce their energy usage at city facilities.
 - Bexar County is moving forward with the installation of flood gates along Poss and Evers. They expect to install them in November.
 - Staff has contacted construction and landscaping companies for the remodel of the restrooms at the Leon Valley Community Pool and installation of landscaping in the adjacent vacant lot. We will be presenting the information to the Pool Advisory Committee meeting on October 30th, then to City Council on November 19th.

- The Grass Hill generator and Forest Meadow drainage improvements projects have started. The Forest Meadow entrance to the park is limited, as this area is in the work zone. Community Gardeners will be able to tend to their plots while the work is in progress.
- Staff has chosen the streets for the FY 2020 Street Maintenance Project, based on their ranking. The City Engineer will now prepare the plans and bid specifications.
- The engineer has begun preparing bid documents for the Grass Hill elevated tank rehabilitation project.
- Plans for ADA sidewalk extensions across the alleys in Linkwood are being developed.
- Staff is getting quotes for new Capital items for the park, which include new picnic tables, a fitness station, and new pavilion.
- Preparing El Verde Road for concrete in front of the fire station.
- Installing picnic tables at parks.
- Cleaning up flood debris at the parka and along Poss and Andres Salazar roads.
- Painting the curbs in front of the library.
- Power washing the Community and Conference Center sidewalks.
- Getting estimates for repairing water main break on Evening Sun.
- Repairing SCADA system.
- Placing new dump truck into service.
- Performing preventative maintenance on Asphalt Zipper in preparation for El Verde road work.
- Staff gave away approximately 140 trees at the Arbor Day event held on Saturday.

The purpose of the "Fire Engineer", under general supervision of the shift Captain, drive and operate apparatus in response to emergency incidents; ensure all associated equipment is in working order; perform fire suppression, emergency medical services and perform related duties as required.
- **Fire Department Continuing Education** (service progression) All Firefighters are completing the Texas Department of State Health Services "The Solution Is Dilution" Certificate of Completion.
- Fire Department Continuing Education (service progression) Congratulations to Angel C. Hernandez who received his Certification of Completion for Instructor 1 through Texas Commission on Fire Protection.
- Ambulance Supplemental Payment Program Cost Report FFY-2018- (Oct 1, 2017-Sept 2018), The Fire Department prepared and submitted the Ambulance Supplemental Payment Program cost report prior to the deadline date to the Texas Health and Human Services Commission (HHSC). Leon Valley is

one of the few agencies in the state of Texas to receive this funding, and this is the 5th year of that recovery. ASSPP submission was completed on Thursday, March 28, 2019. Achievement: \$22,317.70 awarded to Leon Valley Fire Department.

- Fire Recovery USA Recovery Program (cost recovery)- Consisting of incident cost recovery, claim submission in the Fire Recovery Hub database, daily claim management, tracking incident cost recovery from inception to date as well as providing monthly department recovery updates. Achievement: Collection generated \$44,503.73 with a 98% recovery rate.
- Emergicon EMS Recovery Program (cost recovery)- Emergency medical billing and patient care records. Achievement: Fiscal Year 2019, 10/1/18 9/30/2019, maximizing collection recovery of \$344,669.30, average collection of 46% rate for FY 2019 (excluding Medicare / Medicaid (contractual allowances).
- Credit Systems International, Inc. Collections Program (cost recovery)- CSI maximizes the collection of delinquent accounts referred to Agency by Emergicon. Accounts are identified as primary bad debt account with balance over \$50.00 that are between 31 days and two years in age from the date of service. Achievement: November 2017 September 2019, current collection to date is **\$20, 249.30**.
- Annual October Fire Prevention Month (community service) –The Leon Valley Firefighters provides "Fire Prevention Education" October 7th -October 18th, 2019. This years' NFPA campaign theme is "Not Every Hero Wears a Cape: Plan and Practice your Escape!".
