- One Firefighter Vacancy. Two applicants have passed background. Testing is scheduled for June 22, 2016.
- One code enforcement officer vacancy, temporarily being filled by firefighter Todd Morgan.

Public Works

- Preparing for 6/21/16 City Council meeting budget adjustment for Watershed Wise LID grant for parking lot at City Hall, Hodges drive traffic study, Huebner Rd Mill & Overlay.
- Well project underway expect to start construction of SAWS interconnect the week of June 20th
- Bids for the Huebner Road mill & overlay project were opened on June 8th at 2 pm. The low bidder will be brought to City Council at the June 21st meeting
- The RFQ committee for engineering of the Evers Road bridge is meeting this week to select an engineering firm still need to figure out how to fund the bridge
- Street ranking project continuing, with training of Assistant Director and Field Manager
- Working on the stormwater projects that were brought to our attention during the city-wide drainage workshop
- Kinman House construction continuing this week, weather permitting. Will be at the July 19th meeting to request budget adjustment for kitchen equipment.
- Neighborhood Renewal Project was a success, although we need more volunteers the next event will be held in September, to coincide with the large item pickup
- The County has placed our Conestoga Street water and sewer main replacement funding request in their CDBG grant proposals for next year. This project will replace 40 year old lines that have broken on numerous occasions.
- Bexar County Flood Control has published their 100% plans for the LC-17 Phase III project in Huebner Creek The project was advertised Sunday, May 29th and bids will be expected on June 30. If the

bidding process goes as anticipated, this project could be ready to start construction in September/October 2016.

 - Restoring filing system and cleaning up paperwork from previous CEO

Police Department

- On June 13th, had 4 separate accidents on Bandera Road within a 30 minute period.
- One breaking & entering case
- One emergency detention
- One shoplifting case
- Rollover accident on Bandera at Timco with no injuries
- Arrested a male at the Stay Inn Express for several warrants
- Two individuals were issued citations for possession of narcotics paraphernalia
- Officer JoAnn Flores, who was working off-duty, assisted a young child having seizures
- Male was arrested for indecency with a child.
- Officer attempted a traffic stop on Bandera Road, the female driver was arrested for evading arrest and detention and while the Officer was attempting to handcuff the female, the female kicked our Officer.
- Officers working off duty at HEB had a female attempt to steal over \$400 of merchandise. Upon contacting the subject, she fled and the Officers apprehended her near the gas pumps.
- Responded to an accident on Linkwood where the driver had fallen asleep on his way home from work. The driver hit a parked car.
- One vehicle burglary arrest at the Calypso Apartments.

• One arrest in Forest Meadow for assault bodily injury, possession of marijuana, possession of drug paraphernalia, and unlawful restraint.

Library

- Summer Reading Kickoff Concert attended by 65 was a success. Performer Joe McDermott
- Daily activities for children to keep then active and reading all summer.
- Implementing "check out a librarian" and "check a tech" programs. Customers can schedule dedicated time with a librarian or computer tech for help learning new skills, how to research, learn to use ebooks, etc.
- Writing procedure for the recent Policy Manual.
- Collection review finding needs where we should add more or current information on. Expanding Spanish Adult collection courtesy of funding by the Friends of the Library.
- Two summer interns are on board through the end of July to aid with programming and working the desk during our busy season.

Fire Department

- **Training** Firefighters Andy Patterson, Matt Sudell, and Ryan Jones earned their *Swift Water Rescue Technician* certifications. This works towards the department's 2016 goal of improving the Swift Water Rescue response capabilities.
- Succession Planning The department invited the *Program Coordinator* for the Protective Services Department at San Antonio College to meet with each firefighter over a 3-day period and presented information about enrolling in college course degree plans. FIVE Leon Valley Firefighters enrolled in emergency services degree programs. Currently, the fire department has seven (7) employees with a college degree, and thirteen (13) that are currently enrolled and seeking a degree. The intent of the initiative was to improve succession planning and professional development of our team.
- **EMS Administration** The final draft RFP's for both EMS Billing and EMS Debt Collection services have been completed and are scheduled to be published over the next two weekends. - **Fire Station** The fire station generator is broken and is in need of an alternator. The cost of the repair is estimated at \$14,200. The generator is necessary for operations and repairs have been scheduled.

- Staff will be facilitating a Job Fair at the Community Center through the official/co-sponsored city event application rather than by means of an In Kind Grant. This was an idea brought forward by Councilor Jordan.
