Year 6 Street Maintenance

The City Engineer is designing a bid package for Year 6 Street Maintenance in an amount not to exceed \$550,000. We expect to bid this project in February of 2023.

Huebner Elevated Storage Tank

The contractor met with staff last week and was given a Notice to Proceed with a start date of 1/26/23. They will provide a project schedule; however, the project should take about three months to complete. This is the last elevated tank that needs to be rehabilitated and repainted.

Huebner Road School Zone

The engineer conducted a topographical survey and is preparing the plans. All work is being coordinated with the City of San Antonio.

Huebner Creek Flood Control Project Phase 1

The engineer has completed the cross-section survey and is now developing the alignment and proposed layout. Once this is complete, we will come to City Council to get approval of the layout, then we will update the FEMA model and coordinate with SAWS and other utilities in this area.

PUBLIC WORKS

- We are preparing bid documents for the pool replastering/replumbing project.
- Staff is preparing a bid package for the replacement of the El Verde water main.
- Zarzamora Creek cleaning is almost complete.
- Staff has contacted TxDOT to get the status of the grant approval for Segment II of the Hike & Bike Trail. The engineer is in the design and engineering phase.
- Engineering has begun on the Wurzbach Road Sewer Main Replacement Project. The CDBG awarded the City a grant for a portion of the funding, but they won't send formal approval until February.
- A preliminary layout and plan for the impound lot behind City Hall has been prepared. Staff has contacted several electrical companies to get quotes for this work.
- Staff submitted a grant request for funding of the creation of a transportation plan to support the Safe Streets for All initiative.
- Staff and the City Engineer are working on the Huebner Creek Hike & Bike Trail Segment II.
- Staff submitted a grant application for TxDOT funding of another segment of trail, from Evers Road, through Huebner Creek, up to the city limits.
- Staff is working on a Capital Improvements Plan to be presented to City Council in the summer.
- Staff is working on an Impact Fee Study.
- Staff is preparing a water and sewer rate study for City Council.
- Working on repairs to the Police Department section of City Hall. The ground shifted and foundation work will be required.
- Installing fencing along the Linkwood-Pavona Place Trail.
- Replacing sections of trail at Raymond Rimkus Park.
- Replacing 20' of sidewalk along Forest Pine.
- Will be replacing old trail surface at the Linkwood-Pavona Place trail.
- Crack sealing streets for Year 6 street maintenance.
- Painting merry-go-round to get it ready for reinstallation at the park.
- Clearing small trees and brush for the Linkwood-Pavona Place trail fence construction.
- Installing Fire Station shelving.
- Repairing French drain at Raymond Rimkus Park.
- Preparing Huebner elevated storage tank for rehab project.
- Replacing curb stop on Canterfield.

FIRE DEPARTMENT

- Fire Department staff have completed their annual physical and fit-for-duty test without incident.
- The Fire Department completed vehicle extrication training with assistance from Banis Towing. Banis provided the vehicles used for the training. Training included the use of a new Para-tech strut system the fire department acquired last year.
- The Fire Department participated in the STAA Fire Marshal's roundtable discussion series. Our Fire Marshals represented the city in a forum that included the Cibolo Fire Department, the Bexar County Fire Marshal Office, the Seguin Fire Marshal's Office, the Atascosa County Fire Marshal Officer, and the City of San Antonio Planning and Zoning Department.
- The Fire Department is applying to become a Storm Ready community through NOAA and NWS. We will be going through the application process to determine if we meet the minimum requirements. This should be completed by this spring.

ECONOMIC DEVELOPMENT

- City Staff is working on partnering with Lift Fund to start a 0% loan program for qualifying local businesses.
- City Staff is conducting business introductions.
- City Staff is working with the UTSA Small Business Development Partnership to have a local business workshop.
- City Staff will bring a presentation to the City Council on February 21st for the Petland partnership.
- City Staff is working on other business expansion projects.
