FIRE DEPARTMENT

- The Fire Department responded to a large commercial fire at Vista Del Rey, building 39. The structure sustained major damage and were believe the buildings are a total loss. This required more than 40 firefighters to bring it under control. No residents or firefighters were injured.
- The Fire Department responded to a large fire in a commercial storage facility. Several travel trailers, motorhomes, boats, food trucks and other vehicles were heavily damaged along with the structure. This required 26 fire fighters to bring it under control.
- The Fire Department received 18 new box fans for donation. 6 box fans were distributed to LV residents.
- The Blessing Box is still accepting donations. If you know anyone in need of food, please have them come to the fire station for assistance.
- The Fire Department hired a new firefighter / Paramedic to fill 1 of three openings. The fire Chief also has interviewed 2 applicants for the open Deputy Fire Marshal's opening. The City has officially become a Storm Ready city through NOAA and NWS. We will be planning a proclamation on August 1st, 2023.

- Had a site selection for new business to open a location within Leon Valley.
- Had meetings with property managers to push the City as a destination for their new clients.
- Added leasable properties in Leon Valley to the city website.
- Worked with the community relations director to get sponsors and vendors for the 4th of July event.
