**FIRE DEPARTMENT**

- All flood sensors and the HALT gates are operational, as of April 16, 2024, flood sensors are active on [bexarflood.org](http://bexarflood.org). The next step in this project is to integrate the flood warning sirens into the Conrail system. This would automate the operation of the flood sirens in the event of flooding. The current is dependent upon a fire fighter going to LVPD and activating the flood siren. The ongoing issue with this process is that when flooding occurs all LVFD personnel are out in the field. We are in the process of working with an engineering team on the technical aspects of the integration. LVFD assisted with the School of Science and Technology’s field day events last Friday. The school hosts this event every year at the close of the school year for the students to enjoy some outdoor fun. LVFD provided water for the dunking both and several other water-related activities.
- The LVFD received its new UTV that was budgeted this year. This UTV along with a skid mounted sprayer will provide a means of fighting small grass fires in our green spaces. The UTV will also be able to be used for rescue on the trail system for injured visitors.
- of the vehicle. An additional supplement has been submitted for additional repairs. We have requested a completion date from Miricle Paint and Body. The picture below is from 04/29/2024.



- The ambulance damaged in an accident on 07/27/2023 has been delivered back to LVFD. We are in the process of restocking and re-equipping the unit for service. This single accident spurred the LVFD to install forward and rear facing dash camera in all vehicles.
- Fire Fighter / Paramedic Maria Villafranca was asked to speak at a career day event Oak Hills Elementary School. FF/P Villafranca attended the same school for elementary school.
- Assistant Fire Chief Chris Willis has begun the field training portion of his law enforcement training. AFC Willis will be in the LVPD for the next four months.

- The engineer continues designing the El Verde Water Main Replacement Project.
- Staff and the City Engineer continue to prepare the water and sewer rate study.
- The sewer televising and cleaning contractor continues their work.
- Staff is getting estimates to install irrigation systems at the parks.
- The FY 2023 Street Maintenance Project has been completed – a punch list is being developed for final acceptance.
- The FY 2024 Street Maintenance Project is scheduled for bid this month.
- Applied for a CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd – waiting for the Bexar County award in July/August timeframe.
- City engineers are inspecting the foundation under the Fire Department for vapor barrier issue.
- Working on repairs to the Sally Port at the Police Station – the frame has been water damaged and needs to be replaced.
- Preparing for replacement of storefront area at City Hall near Council Chambers.
- The Park Commission and staff are revising the Park Master Plan.
- Repairs to Huebner Creek at Poss and Cherryleaf were delayed due to rain and equipment delays. They will start on June 10th.
- Constructing base for new Impound lot.
- Installing curb along Aids Drive.
- Repairing stop sign on Hodges at Evers.
- Mowing Zone 2 – Parks.
- Repairing fence at Linkwood – Pavona Trail.

- Rebuilding water sheds at Fire Station.
