FIRE DEPARTMENT

- The Fire Department has seen a sharp rise in narcotic overdoses in our area. This current streak
 involves heroin mixed with fentanyl. Our Medical Director, Dr. Sparkman, is working with our
 department to hand out Narcan nasal spray to endangered residents who pose an overdose risk.
 This medication will be dispensed through the Office of the Medical Director at UT Health.
 This program is ongoing.
- The Fire Department is proud to announce that Lt. Chris Willis and Capt. Jeremie Ross have completed the Basic Peace Officer Course. Both will be commissioned as arson investigators by the Leon Valley Police Department and will begin 14 weeks of field training.
- The Fire Department continues working on the federally mandated Medicare Gound Ambulance Data Collection Instrument. This report will be used nationally to calculate ground ambulance reimbursement levels for Medicare payments. This report is due by October 31,

- 2023. We are currently at 56% complete. Failure to comply will result in a 10% reduction in Medicare reimbursement to Leon Valley EMS.
- Reserve EMT Zach Conover is completing the skills sessions of the basic fire academy. Upon completion, Zach will be a firefighter / Basic EMT and is scheduled to start Paramedic school in January. Zack graduated from John Marshall HS last year and received scholarships to cover all his fire and EMS training.
- Lt. Chris Willis has secured grant dollars for water rescue training in the amount of \$1241.94.
- Lt. Chris Willis applied for and received grant funding through the Texas Intrastate Mutual Aid System to cover \$2,700 for live fire training for all personnel. This is conducted at the San Antonio Fire Academy Burn House. This training is scheduled for October 28 and 29, 2023.
- The ambulance damaged in an accident on 07/27/2023 is still at Miracle Paint and Body waiting for body parts from the ambulance manufacturer. We receive weekly updates on the progress and anticipate completion of all repairs in the next 3 months.
- The fire department will have a temporary Fire Chief for a day coming later in the month. The LVFD and Driggers Elementary PTA auctioned "Fire Chief for a Day". This student will be given an in-depth tour of all fire department facilities and equipment. This student will be given a ride in a fire truck and will be given a chance to flow some water and take some photos in bunker gear. This is a reoccurring program and the LVFD is pleased to participate annually.
- The Fire Department completed 401 hours of training in fire and EMS.
