### **Projects**

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

## **Garbage Collection Rate Increase**

Although the annual Consumer Price Index (CPI) calculation specified in the City's contract with Tiger Sanitation is in excess of 2.5%, the contract caps the rate increase to a maximum of 2.5% unless the Contractor petitions the City for an additional increase. Tiger Sanitation is not petitioning the City for any additional rate increase above 2.5% at this time. The new rates for garbage collection (2.5% increase) will take effect January 1, 2024.

#### ECONOMIC DEVELOPMENT

- Had a Zoom meeting for a new cooperate business to relocate to the Leon Valley area with the help of Greater SATX.
- Friday meet and greet with local business owners.
- Held grand opening for Hello Pizza.
- Recruited businesses to participate in Blue Santa program.
- Complete the sales tax report and posted on the City website.

### FIRE DEPARTMENT

- The Fire Department continues to dispense Narcan to our endangered residents and visitors. This medication will be dispensed through the Office of the Medical Director at UT Health. This program is ongoing and, to date, has dispensed over 24 doses. The Fire department has already distributed four boxes to endangered residents.
- The Fire Department will begin our annual testing and maintaining of fire hydrants throughout the city. This testing is vital to ensure that in the event of emergencies, the fire department will have a reliable water supply. Part of the testing includes flushing the hydrants which will cause water in the streets.
- The ambulance damaged in an accident on 07/27/2023 is still at Miracle Paint and Body, waiting for body parts from the ambulance manufacturer. We receive weekly updates on the progress and anticipate completion of all repairs in the next 3-6 months. The vehicle portion of this repair is ready for paint while work continues to the box portion of the vehicle.
- The fire department is working on securing an appropriate cab and chassis for our new ambulance budgeted for this Fiscal Year. There is currently a nationwide shortage of ambulance conversion chassis.
- The fire department participated in the Total Quality Logistics Fall Fun Bash on Exchange Parkway. The fire department provided truck tours and handed out fire prevention materials to both young and old.
- The Fire Department completed 439.8 hours of continuing education training in fire and EMS.
