PUBLIC WORKS

- For Seneca West project. The contractor is waiting for the installation of a gate, but the project is otherwise completed. The engineer will now submit the plan of record to obtain a Letter of Map Revision (LOMR) to revise the floodplain maps.
- The engineer is in the design phase for the Hike & Bike Trail Segment II.
- Staff is working on an Impact Fee Study and water and sewer rate study.
- The sewer televising and cleaning contractor continues with their work.
- Plans for the FY 2024 Street Maintenance Project are underway. The targeted neighborhood is Grass Valley.
- Engineering and design are underway for the second portion of the Wurzbach Sewer Main Replacement Project.
- Renovating the kennel behind Public Works.
- Laying asphalt along Aids Drive.
- Mowing rights-of-way city-wide.
- Changing the a/c filters at all buildings.
- Repairing fence at Forest Oaks Pool.
- Addressing service requests.
- Painted over graffiti on trees in Huebner-Onion Natural Area Park.
- Installing final decorations for the Holiday Lighting Ceremony and decorations at City Hall.
- Repaired a sewer main back up on Forest Mont.
- Televising sewer main on Forest Mont to determine why there was a sewer backup.
- Two crew members will be attending water class.
- Performing meter and service line inventory per the TCEQ.
- Repairing two curb stops.
- Meeting with leak detection team.
- Installing new water service in Linkwood.

FIRE DEPARTMENT

- The Fire Department delivered a full food donation barrel of food to be distributed by the Holmes High School ROTC program. This food donation was used to fill baskets for Thanksgiving meals to the needy.
- The Fire Department hosted a tour from a home-schooling coalition group. This included adults and elementary school-aged children. All the children that attended brought can good and unwrapped toys for the upcoming Christmas season.
- The Fire Department continues our annual testing and maintenance of fire hydrants throughout the city. This testing is vital to ensure that in the event of emergencies, the fire department will have a reliable water supply. Part of the testing includes flushing the hydrants which will cause water in the streets.
- The ambulance damaged in an accident on 07/27/2023 is still at Miracle Paint and Body, waiting for body parts from the ambulance manufacturer. We receive weekly updates on the progress and anticipate completion of all repairs in the next 3-6 months. The vehicle portion of this repair is ready for paint while work continues to the box portion of the vehicle.
- The Fire Department is working on securing an appropriate cab and chassis for our new ambulance budgeted for this FY. There is currently a nation-wide shortage of ambulance

conversion chassis. We have found pricing pending with three dealers currently and are exploring more distant Dodge dealers.

- The Fire Department completed our interview and documentation request for Fitch and Associates for the staff study. The Fitch consultants toured our department and were provided with a tour of some of our high-hazard areas.
- The Fire Department completed 145 hours of continuing education training in fire and EMS.
