

### FIRE DEPARTMENT

• The FD and several mutual aid departments responded to a structure fire in a commercial business on Wurzbach Road on 02/16/2024. Upon arrival, the fire was through the roof on the rear of the building. Several homeless people were on-site and had to be removed from the immediate area for safety reasons. The building was not occupied at the time and had not been for several years. The building had no utilities connected at the time of the fire and showed signs of vandalism. The fire was extinguished using our ladder truck, several handlines and 21 firefighters. The fire is under investigation.



- High Seirra has completed necessary repairs and upgrades to the HALT gate system. These repairs included sensor replacement in the flood way, cross arm repair, and system testing. The HALT gate computers were upgraded to the latest version, allowing better integration with the Bexar County Contrail flood monitoring systems. We are still working to integrate the existing flood warning sirens in the HALT gate system for automatic sounding. Both systems will be housed in the FD server room, which will allow emergency personnel better access to the systems.
- The fire alerting system and radios for the station were upgraded to ensure reliability and effective alerting for emergency dispatches. The previous systems were extremely outdated and were moved from the old fire station and not updated. The FD is still working to correct several installation issues related to improper installation of the previous systems.
- The ambulance damaged in an accident on 07/27/2023 is still at Miracle Paint and Body waiting for body parts from the ambulance manufacture. We receive weekly updates on the progress and anticipate completion of all repairs in the next 3-6 months. The vehicle portion of this repair is ready for paint while work continues to the box portion of the vehicle. An additional supplement has been submitted for additional repairs. We have requested a completion date from Miricle Paint and Body.
- The Fire Department is securing an appropriate cab and chassis for our new ambulance budgeted for this FY. There is currently a nation-wide shortage for ambulance conversion chassis. We have found pricing pending with three dealers currently and are exploring more distant Dodge dealers. This project has spread to out of state dealers as suggested by the ambulance vendor.
- The Fire Department will begin scheduling Stop the Bleed classes for all City employees. These classes will be taught in the FD training room and will be in groups of 5. This will

allow all employees sufficient time to practice the needed skills. Coordination for these classes will be through AFC Willis.
