FIRE DEPARTMENT

- With the recent rain events, we have closely monitored the flood warning system and it has
 worked without issue. This item will be removed from the CM report but will remain on
 our radar and will be monitored closely.
- The LVFD continues to work with BCSO and STRAC to ensure response times are being separated and reported correctly in our reporting system. We are currently working on customs reports to ensure we can separate our times as suggested in best practices policies.
- The ambulance damaged in an accident on 07/27/2023 is still at Miracle Paint and Body and should be completed this week. The main take-away is that it took 10 months to repair an ambulance. The picture below is from 05/12/2024.



- Deputy Fire Marshal Jeremy Ross has completed four months of field training in the police department. DFM Ross completed the law enforcement academy in October 2023 and began the FTO program on January 2024. DFM Ross is now a fully qualified law enforcement officer, licensed by the State of Texas and LVPD.
- Assistant Fire Chief Chris Willis has begun the field training portion of his law enforcement training. AFC Willis will be in the LVPD for the next four months.

PUBLIC WORKS

- The engineer has started designing the El Verde Water Main Replacement Project.
- Staff has finalized the Impact Fee Study and will present it to City Council on the 7th adoption scheduled for May 21st.
- Staff and the City Engineer continue to prepare the water and sewer rate study.
- The sewer televising and cleaning contractor continues their work.
- Staff is getting estimates to install irrigation systems at the parks.
- Year 7 Street Maintenance plans are almost ready. Bid in June and awarded in July. Work will start in August. Targeting the Grass Valley neighborhood as they had the lowest scores.
- We are applying for a CDBG grant to replace the sewer main in the alley between Cammie Way and Evers Rd.
- Finishing repairs to the Kinman House foundation.
- City engineers are inspecting the foundation under the Fire Department for vapor barrier issues.
- Working on repairs to the Sally Port at the Police Station the frame has been water-damaged and needs to be replaced.
- Preparing for the replacement of the storefront area at City Hall near the Council Chambers.
- The remodeling of the Conference Center to install a kitchen area is almost complete.
- The Park Commission and staff are revising the Park Master Plan.
- Wurzbach Sewer CDBG plans are almost ready. Bid in June and award in July. Work will start in August and will take about a month.
- Repairs to Huebner Creek at Poss and Cherryleaf were delayed due to rain and equipment delays.
- They will start on June 10th. Repairing driveway approach on Mike Nesmith.
- Power washing unknown fluid on El Verde Road.
- Mowing Zone 2 Grissom and Poss Roads.

- Repairing fence at Linkwood Pavona Trail.
- Performing make-ready on Forest Oaks Pool.
- Rebuilding water sheds at Fire Station. Performing meter and service line inventory per the TCEQ.
- Running sewer camera at Forest Oaks pool.
- Replacing dead meters and broken curb stops.
- Repairing water leak at the meter at City Hall.
- Installing curve ahead signage on Poss Road.
- Mowing Zone 2 Bandera Road.
- Installing new park trail signage.
- Cleaning out Zarzamora Creek at 5601 Bandera.


