FIRE DEPARTMENT

- All flood sensors and the HALT gates are operational, as of April 16, 2024, flood sensors are active on bexarflood.org. The next step in this project is to integrate the flood warning sirens into the Contrail system. This would automate the operation of the flood sirens in the event of flooding. The current is dependent upon a fire fighter going to LVPD and activating the flood siren. The ongoing issue with this process is that when flooding occurs all LVFD personnel are out in the field. We are in the process of working with an engineering team on the technical aspects of the integration.
- The LVFD has migrated to a new regional fire and EMS reporting system effective 04/01/2024. This regional reporting system is through STRAC and Bexar County Dispatch and is used by the surrounding seventeen counties. The reporting module is currently up and running.
- The ambulance damaged in an accident on 07/27/2023 is still at Miracle Paint and Body waiting additional door frame parts from the ambulance manufacture. We receive weekly updates on the progress and anticipate completion of all repairs in the next 60 days months. The vehicle portion of this repair is ready for paint while work continues to the box portion of the vehicle. An additional supplement has been submitted for additional repairs. We have requested a completion date from Miricle Paint and Body. The picture below is from 04/29/2024.



• The FD has completed Stop the Bleed classes for all City employees. If anyone missed this training, please get with Assistant Fire Chief Willis to schedule. All Leon Valley fire

personnel along with Balcones Heights FD attended Live Fire Training at San Antonio College Regional Fire Academy on April 20th and 21st. We have started the Defensive Driving Class that is being taught by the Police Department, FD last class will be on May 7th, in our training room.

PUBLIC WORKS

- The engineer has started designing the El Verde Water Main Replacement Project.
- Staff and the City Engineer continue to prepare the water and sewer rate study.
- The sewer televising and cleaning contractor continues their work.
- Year 7 Street Maintenance plans are almost ready. Bid in June and awarded in July. Work will start in August. Targeting the Grass Valley neighborhood as they had the lowest scores.
- We are applying for a CDBG grant to replace the sewer main in the alley between Cammie Way and Evers Rd.
- We are working on repairs to the Kinman House. The foundation on the Forest Pine side of the structure is sinking.
- City engineers are inspecting the foundation under the Fire Department for vapor barrier issues.
- Working on repairs to the Sally Port at the Police Station the frame has been water damaged and needs to be replaced.
- Preparing for the replacement of the storefront area at City Hall near the Council Chambers.
- The remodeling of the Conference Center to install a kitchen area has begun.
- The Park Commission and staff are revising the Park Master Plan.
- Huebner Road school zone is complete and operational. Lights will flash from 7 am to 9:30 am and from 4 pm to 5:30 pm for the high school schedule.
- Wurzbach Sewer CDBG plans are almost ready. Bid in June and award in July. Work will start in August and will take about a month.
- Seneca at Royal Sun concrete overlay work will start on May 13th and will take several days as we are trying to keep the street open to traffic. Work consists of overlaying the broken concrete pad near the intersection of Evers and Seneca.
- Poss at Cherryleaf Huebner Creek erosion control Work starts May 13th and may take about a month
- Constructing base for new Impound lot.
- Repaired multiple potholes on Blackberry.
- Beginning work back on Mow Zone 1.
- Installing engineered mulch at Rimkus Park playgrounds.
- Performing graffiti abatement.
- Removing some debris and branches leftover from weekend thunderstorm.
