SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- Staff and the City Engineer presented the water and sewer rate study to the City Council on July 16th. Council direction was to wait until the Capital Improvements Plan is completed before determining any increase in water and sewer rates. The plan is expected to be completed in September.
- The sewer televising and cleaning contractor has let us know that they have about two more months to complete their work. We will be meeting with them every Tuesday until the job is complete.
- Staff is getting estimates to install irrigation systems at the parks and will start with the Silo Park.
- The FY 2024 Street Maintenance Project bids have been opened and this item will go to the City Council for award on August 6th.
- City engineers are inspecting the foundation under the Fire Department for vapor barrier issue.
- Preparing for replacement of storefront area at City Hall near Council Chambers.
- The Park Commission and staff are revising the Park Master Plan. A survey has been posted on the City's website and paper copies have been placed at the library, City Hall, and the Forest Oaks pool.
- Repairs to Huebner Creek at Poss and Cherryleaf continue

Additional Public Works Activities

- Installing 37 linear feet of new sidewalk along Crownpiece.
- Completing service requests from water utility repairs.
- Mowing the LV Community pool and the Stirrup Trail.
- Making improvements to the new vehicle impound lot.
- Disconnecting and reconnecting water services.
- Performing meter and service line inventory per the TCEQ.

- Replacing residential and commercial malfunctioning meters.
- Repairing sewer main leak at Bandera and Huebner.
- Mowing well sites.
- Repairing backhoe fluid lines and a bypass on the other one.
- Performing PM on equipment and vehicles.
- Finishing up the mowing of Stirrup Trail, Triangle Park, and the Huebner-Onion Homestead property.
- Making improvements to the City Hall fence between the new vehicle impound lot and El Monte.

PW GRANTS

- The engineer continues designing the El Verde Water Main Replacement Project. This project will be funded by a \$1,300,000 Bexar County ARPA grant.
- Applied for a Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd waiting for award from Bexar County in July/August timeframe.
- The City Engineer received direction from the City Council to follow a new alignment
 for the Huebner Creek Erosion Control Project and is in the process of redesigning it to
 follow the existing creek. Staff applied for a Texas Water Development Board (TWDB)
 Flood Infrastructure Fund (FIF) grant and a FEMA Flood Mitigation (FMA) grant for
 project funding.
- The CDBG funded grant for the Wurzbach Vista Del Rey sewer main replacement project was awarded and staff advertised bids for the project. The Bexar County CDBG will not accept only one bid, so we are readvertising the project and including the other sewer main near the Ancira Body Shop in the package. The bid came in very low, as the project was designed to be cast in place concrete, so we are able to include more sewer main replacement.
- Bexar Branches Alliance has successfully secured grant funding to acquire 225 trees to be planted along the Hike & Bike Trail. The funding will come from the Arbor Day Foundation and Cox Enterprises. The city's portion of funding is approximately \$4,230. The tree will range in size from 5 to 15-gallon sizes and the Alliance will provide the following additional planting support:
 - o \$2,500 for the irrigation supplies necessary for the trees planted as part of this initiative.
 - Furnish volunteers with essential supplies, including food, hydration, tools, and gloves.
 - Provide a licensed landscape architect to develop a comprehensive planting plan, encompassing potential irrigation strategies to ensure the long-term success and vitality of the newly planted trees.
- Bexar Branches Alliance is assisting the city with the submittal of a \$110,000 grant to plant 600 trees in the Huebner-Onion Natural Area Park. This will go to the City Council for approval once the details have been finalized.



FIRE DEPARTMENT

- LVFD is working to move the flood siren warning system controls out of the police department to the fire department server room. We are scheduled to have the new antenna system installed at the FD that connects the siren controller to the siren towers. Once completed, we will move the siren controller and radio to the FD. We anticipate completing this system move by the end of August.
- All LVFD fire fighters are in the process of completing our annual physicals and health screening. This testing includes fitness, respiratory function, cardiac, hearing, vision and mental health. Last year, this screening caught colon cancer in a fire fighter which was unknow at the time. This was treated immediately, and the fire fighter returned to full duty several weeks later.
- LVFD remains in the running for a grant to provide funding for a brush truck. This is a 90/10 grant through the Texas Forest Service and Texas A&M Extension Service. The FD will continue to apply for this grant until we receive an award.
- The LVFD continues to work with BCSO and STRAC to ensure response times are being separated and reported correctly in our reporting system. We are currently working on customs reports to ensure we can separate our times as suggested in best practices policies.
- The LVFD is once again soliciting donations for our school supply drive. We will have yellow containers located at LV Library, City Hall and at the FD. These supplies will support our three local elementary schools.
