**SUBJECT:** Pre-City Council Meeting Report

#### **Projects**

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

#### **Public Works**

- The Capital Improvements Plan is expected to be completed in September. This plan will determine what type of water and sewer rate increase is needed. A workshop is planned for October 19<sup>th</sup> with the City Council.
- The sewer televising and cleaning contractor has let us know that they have about one more month to complete their work. We are meeting with them every Tuesday until the job is complete.
- The FY 2024 Street Maintenance Project was awarded. The pre-construction meeting was held, and the contractor anticipates starting on the flatwork the third week of September.
- City engineers are inspecting the foundation under the Fire Department for vapor barrier issue.
- Replacing the storefront area at City Hall near Council Chambers.
- The Park Commission and staff are revising the Park Master Plan. A survey has been posted on the City's website and paper copies have been placed at the library, City Hall, and the Forest Oaks pool.
- Repairs to Huebner Creek at Poss and Cherryleaf are complete. Staff will have a walk-through with the contractor before final payment is issued.
- Staff met with the Channing's Joy Foundation to determine the location of the autism communication boards at each of the playgrounds in our parks. They will now design the boards.

#### **Additional Public Works Activities**

- Repairing sidewalks along Pacer Trail and Pecan Acres.
- Repairing damaged asphalt at Finley Apartments due to a water main break.
- Completed mowing Bandera Rd., and completing the Huebner Creek.
- Beginning Mow Zone 3.

- Finishing fence at PD impound lot.
- Working on irrigation in Rimkus Park, and watering trees.
- Performing meter and service line inventory per the TCEQ.
- Investigating SCADA error messaging.
- Repairing water main break at 6838 Bandera Road.
- Replacing residential and commercial malfunctioning meters.
- Repairing water truck.
- Repairing trailer.
- Assisting with upcoming vehicle auction.

#### **PW GRANTS**

- The engineer continues designing the El Verde Water Main Replacement Project. This project will be funded by a \$1,300,000 Bexar County ARPA grant.
- Awarded a Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd – project will now be advertised for bids.
- The City Engineer received direction from the City Council to follow a new alignment
  for the Huebner Creek Erosion Control Project and is in the process of redesigning it to
  follow the existing creek. Staff applied for a Texas Water Development Board (TWDB)
  Flood Infrastructure Fund (FIF) grant and a FEMA Flood Mitigation (FMA) grant for
  project funding.
- The CDBG funded grant for the Wurzbach Vista Del Rey sewer main replacement project was awarded and staff advertised bids for the project. The Bexar County CDBG will not accept only one bid, so we are readvertising the project and including the other sewer main near the Ancira Body Shop in the package. The bid came in very low, as the project was designed to be cast in place concrete, so we are able to include more sewer main replacement.
- Bexar Branches Alliance has successfully secured grant funding to acquire 225 trees to be planted along the Hike & Bike Trail. The funding will come from the Arbor Day Foundation and Cox Enterprises. The city's portion of funding is approximately \$4,230. The tree will range in size from 5 to 15-gallon sizes.
- Bexar Branches Alliance is assisting the city with the submittal of a \$110,000 grant to plant 600 trees in the Huebner-Onion Natural Area Park. This will go to the City Council for approval once the details have been finalized.



#### FIRE DEPARTMENT

- LVFD completed the migration of the flood warning system to the fire department. This will allow faster responses to flood warning activations. Our next step is to get the flood warning server repaired and reactivated and placed back into service.
- The Flood Emergency Response Plan was activated twice in the last two weeks. Both times, the floodgates and warning system operated without issue. We are currently working to get the flood sensors along Zarzamora Creek back on-line and monitored. Once this is completed, Bexar County OEM will monitor it.
- On Saturday, September 14, 2024, the LVFD will be delivering 300 pounds of canned goods to St. Johns Baptist for their food distribution to needy families.
- The LVFD continues to work with BCSO and STRAC to ensure response times are being separated and reported correctly in our reporting system. We are currently working on customs reports to ensure we can separate our times as suggested in best practices policies.
- The LVFD responded to the Kendall County bleacher collapse on August 31, 2024. This was a regional response for ambulances and strike teams for 20+ patients. LVFD sent a single ambulance to the staging area and provided patient care. This was a large-scale response initiated through STRAC.

#### INFORMATION TECHNOLOGY

- Council Chambers RFP: Deadline of 9/9/2024 yielded only two proposals. Deadline to submit extended to 10/7/2024. Two vendors known to be preparing proposals. One more to do site walk this week.
- 48 Port switch at the library failed to pass traffic and had to be replaced with a new switch. Frank with TecHLP helped install the switch. I will be enlisting TecHLP's assistance to move the server rack from its current location to the new location in the loft of the library. This will require moving many cables to the new location.
- Worked with Cardinal Support to clear a long-standing issue with Lexis Nexis service stopping and preventing crash reports from being sent to the state. We are looking into monitoring this service as well as the preventative maintenance schedule for the PD servers.
