SUBJECT: Pre-City Council Meeting Report

Projects

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

Public Works

- Staff presented the Capital Improvements Plan to the City Council on October 19th. A short presentation was held in November on potential funding from the Texas Water Development Board and the EPA. This item will be presented to the Town Hall meeting participants on January 25th.
- The final draft of the Park Master Plan was recommended for approval by the Park Commission on December 12th. The Plan has been placed on the city website for 30 days to gather any last-minute input from the citizens, then it will go to the City Council for final approval.
- The new dog kennel facility is scheduled to be delivered the first week of February.
- The City Engineer is working on plans for the FY 25 Street Maintenance Project. This year we will tackle a portion of Wurzbach Road.
- Staff is evaluating the water and sewer main priority list to determine which mains to replace as a project for this spring.
- Staff is in the process of closing on the purchase of 105-acre feet of water rights.

Additional Public Works Activities

- Starting on the slab for the new dog kennel.
- Repairing sidewalk on Forest Meadow.
- Removing holiday decorations.
- Meeting with electricians to set meter for new kennel.
- Disconnecting & reconnecting water services.
- Reading meters.
- Taking water samples.
- Running water service line for new dog kennel.
- Replacing dead meters.
- Assisting with online vehicle auction.

- Fulfilling service requests.
- Repairing riding lawnmowers.
- Clearing out vehicles and trash from existing impound lot.
- Repairing sidewalks city-wide, weather permitting.
- Gearing up for potential ice event this week.

PW GRANTS

- The engineer continues designing the El Verde Water Main Replacement Project. This project will be funded by a \$1,300,000 Bexar County ARPA grant.
- A Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd was awarded January 7th. The project is being engineered, designed, and will be advertised for bids.
- The City Engineer received direction from the City Council to follow a new alignment for the Huebner Creek Erosion Control Project and has redesigned it to follow the existing creek. Staff applied for a Texas Water Development Board (TWDB) Flood Infrastructure Fund (FIF) grant and a FEMA Flood Mitigation (FMA) grant for project funding.
- The CDBG East of Wurzbach Sewer Main Replacement Project bids were opened last week and the City Engineer has reviewed them and made a recommendation. This item will go to City Council on January 21st for award.
- Bexar Branches Alliance is assisting the city with the submittal of a \$110,000 grant to plant 600 trees in the Huebner-Onion Natural Area Park. This will go to the City Council for approval once the details have been finalized.
- Staff and the City Engineer continue to develop the plans for the Hike & Bike Trail Segment II and have met with TxDOT for a review of the 30% engineering and design. We will now be submitting for environmental and bridge review. The trail is a part of a reimbursement grant from the AAMPO and TxDOT. Letting the project for bids is expected in October of 2025.

FIRE DEPARTMENT

- With colder weather coming, we would remind all residents that rain and ice cause tree limbs over the street to sag. This sagging obstructs the right of way, delaying emergency vehicles responding to calls. In some cases, completely block emergency vehicles. 403.2.1 Dimensions. Fire apparatus access roads shall have an unobstructed width of not less than 20 feet, exclusive of shoulders, except where a fire hydrant is located on a fire department access road, in which case the minimum road width shall be 26 feet. An unobstructed vertical clearance of not less than 14 feet and shall be required and maintained at all times. Security gates shall be sized to match the required clear width.
- Please remember that the LVFD is always willing to help change smoke detector batteries for residents who need assistance, please contact us and we will schedule an appointment.
- LVFD is close to finishing the fire hydrant testing. Our Crews are still out testing our fire hydrants throughout the city.
- The Fire Department had another wonderful year doing the Santa Runs. We have received a lot of feedback from the community and are working to improve the Santa Runs for next year.
