**Projects**

In addition to outside agency review constraints, these projects may also be delayed by weather and supply chain slowdowns.

**Public Works**

- Staff presented the Capital Improvements Plan to the City Council on October 19th. A short presentation will be held in November on potential funding from the Texas Water Development Board. This item will be presented to the Town Hall meeting participants in January of 2025.
- The FY 2024 Street Maintenance Project contractor is finishing the mill & overlay of the Grass Valley neighborhood streets.
- The storefront glass and doors at City Hall near Council Chambers is almost complete.
- The Park Commission and staff are revising the Park Master Plan.
- The Channing's Joy Foundation shipped the remaining autism communication boards and we will now get them installed.
- Getting quotes for the new dog kennel facility.
- Finalizing documentation for the purchase of 105-acre feet of water rights.
- The City Engineer is working on plans for the FY 25 Stret Maintenance Project. This year we will tackle a portion of Wurzbach Road.

- Worked on irrigation in Rimkus Park.
- Continue Watering trees along the hike & bike trail.
- Ordered new tractor.

- Repairing vacuum truck.
- Locating commercial irrigation meters to start drought surcharge billing.
- Replacing the air release valve at Leslie's Pools facility.
- Replacing curb stops.

#### **PW GRANTS**

- The engineer continues designing the El Verde Water Main Replacement Project. This project will be funded by a \$1,300,000 Bexar County ARPA grant.
- Awarded a Bexar County CDBG grant for replacing the sewer main in the alley between Cammie Way and Evers Rd – project will now be advertised for bids.
- The City Engineer received direction from the City Council to follow a new alignment for the Huebner Creek Erosion Control Project and is in the process of redesigning it to follow the existing creek. Staff applied for a Texas Water Development Board (TWDB) Flood Infrastructure Fund (FIF) grant and a FEMA Flood Mitigation (FMA) grant for project funding.
- The CDBG funded grant for the Wurzbach Vista Del Rey sewer main replacement project was awarded and staff advertised bids for the project. The Bexar County CDBG will not accept only one bid, so we are readvertising the project and including the other sewer main near the Ancira Body Shop in the package. The bid came in very low, as the project was designed to be cast in place concrete, so we are able to include more sewer main replacement.
- Bexar Branches Alliance is assisting the city with the submittal of a \$110,000 grant to plant 600 trees in the Huebner-Onion Natural Area Park. This will go to the City Council for approval once the details have been finalized.

### FIRE DEPARTMENT

- The LVFD received an inspection from the Texas Department of State Health Services covering all aspects of our EMS system. The system, policies, procedures, standard operating guidelines, and a top to bottom inspection of two ambulances. This was a three-hour inspection. The LVFD received a 100% on all three sections of this inspection.

- The LVFD firefighters continue to provide fire prevention classes at our local schools. There is not enough crews and vehicles to complete everything during fire prevention week. Our crews also visit most of the daycare centers and senior daycares providing appropriate fire prevention messages.
- LVFD would like to thank the NW Senior Citizens for their donations of diapers and formula which is donated to the Texas Diaper Bank. The Seniors incentives for donating to this project.
- Please remember that the LVFD is always willing to help change smoke detector batteries for residents who need assistance.
- LVFD is out in the apartment complexes currently testing fire hydrants. Crews are making sure that there is adequate water supplies in the event of emergencies. These hydrants are privately owned by the complexes and all maintenance is the responsibility of the complex. LV has several properties that are serviced by private fire hydrants. These include schools, shopping centers, apartments, and other businesses.
