### YOUR LEON VALLEY CITY COUNCIL

The May 4th Leon Valley election for Mayor and Place 2 & Place 4 seats resulted in one change in members on council. Councilman Josh Stephens decided not to run for re-election and Betty Heyl was elected unopposed. Betty and her husband David, raised two daughters and have lived in Leon Valley for 45 years. Betty has served on the Board of Adjustment as Vice Chair and a member of the Citizens Police Advisory Committee. Betty worked for 35 years at the University of Texas Health Science Center in Cardiology Research and Research Imaging Center. She is a passionate animal advocate, among other interests.

Councilman Rey Orozco was re-elected for a third term, unopposed. Rey is a U.S. Army veteran who purchased the first home in Pavona Place in 1996. He had a 37 year career with the V.A. Hospital. He started in the mail room and ended his career as the Deputy Director. He is married to Yvonne and they have six children between them. He loves the Texas Longhorn football team!

I was re-elected for an elev-

enth term by a margin of 81%, for which I am very grateful. My husband Darby and I have lived in Leon Valley since 1978 and raised our three children here. I love my job of serving the citizens of Leon Valley! Returning to council to complete the second year of their two year terms are Councilmen Philip Campos, Benny Martinez and Will Bradshaw.

Some interesting statistics from the election results: There are 7,756 registered voters in Leon Valley but only 482 voted in the May election, for a 6.2% overall turnout. Bexar County's turnout was 3.01%. Thanks to all who voted for caring and expressing your opinion as to who should lead the city.

I also want to thank everyone who opened their door and spoke with me during the campaign. It was very fulfilling to hear from you, my boss, as to how things are going in our community. About one out of 10 citizens had a concern – the majority of citizens I spoke to were happy with the way the city is running.

Here are some consistent concerns I heard: more police presence; speeding and how can we



slow down cars (many want police to write more tickets and asked about speed humps); flooding issues; homelessness; oak wilt; garbage issues; what to do with feral cats; sign ordinance for political signs; code enforcement; slurry seal schedule for street maintenance. All concerns were sent to City Manager Caldera are being addressed. A Council retreat will be set this summer to address council concerns and/or clarify or receive new information.

My overall observation from walking the neighborhoods in Leon Valley: our city is slowly changing to a younger population. The majority of residents have kept up their homes and it shows. Many long-time residents have moved or passed away. I look forward to continue working with the council in a spirit of good-will to address the many issues facing our community. The Council's goal

## **BEXAR COUNTY 911 DISPATCH CENTER**

On April 27th, at the Coffee with the Mayor and Council, City Manager Caldera and Deputy Director of Bexar 911 Center, Eddie Taylor gave presentations on the history and current status of Leon Valley's dispatch services. Our city had its own dispatch center through November 2015. Due to high costs and change in staffing requirements/training, Council signed a 5 year contract with Helotes to provide city dispatch services. In the summer of 2017, the City's annual budget could not support the Helotes contract and the City moved to the newly opened Bexar County 9-1-1 Dispatch Center on Quarry Run. It is a state of the art \$60 million facility made of reinforced concrete and steel, which can withstand an EF3 tornado. The building includes three levels of redundancy, meaning it has triple back up for basic services (water, electricity) and resists mold, dust and allergens. The facility was built with fees collected from cell phone usage and is debt-free. The annual operational cost is \$2 million. In times of an emergency, it serves as the Incident Command Center. Leon Valley's property taxes paid to Bexar County cover all our costs.

The Bexar County 9-1-1 Center contains 104 workstations in a 13,900 sq. ft room with a 50 foot video wall – 88 panels - in the main dispatch room. As calls come into the center and are

dispatched out, they are listed as priority, non-emergency, or report only. Our average emergency response time from call to responders' arrival at the site is 5 minutes 46 seconds.

Of all the 911 calls received at the dispatch center, 38% are attributed to our city. All call takers and dispatchers are trained and are given support in their stressful job. Please call 9-1-1 for emergency calls or (210) 684-8897 for non-emergency calls (On non-emergency calls, Mr. Taylor emphasized not to hang up if you are on hold. If you do, you start at the end of the line). We are grateful to our police and fire department for the 24/7 excellent service they provide our citizens. A main reason people choose to live in Leon Valley is to receive outstanding emergency services!

### **DID YOU KNOW?**

Household Hazardous Waste Drop Off – on Saturday, April 27th at the Fire Department was a HUGE success. We had 238 cars (all residents of Leon Valley) drop off hazardous waste, including electronics. The city received a

grant from San Antonio River Authority for \$15,000, but due to the response the City of Leon Valley will pick up the balance of the cost which is not known at this time. Thanks to all of our Directors who volunteered their Saturday to help with collection as well as to Crystal Miranda, Community Events Director who wrote the successful grant!

City Council Meetings Cancelled for Summer Break: There will be no city council meetings scheduled for June 18th or July 2nd. The city council will be back to their twice monthly meetings beginning July 16th.

Hope to see everyone at the 4th of July celebration in Rimkus Park! The Leon Valley Historical Society, in partnership with the City, will again sponsor the Pioneer Firecracker 5K Fun Run/Walk at 7:30 a.m. At 7 pm the 4th of July Parade will begin at Evers and Huebner to the park, followed by food, music by the band Finding Friday and a high altitude fireworks display at dusk!

Your house should have the address numbers displayed with large numbers, a minimum of 3 inches tall. The numbers should be clearly visible from the street.



Your mailbox should have the address numbers on both sides. Reflective numbers will help us at night.



**Having your address numbers clearly identified will save valuable time in an emergency.**

# 911 ADDRESS NUMBER STANDARDS

IF WE CAN'T FIND YOU QUICKLY, THEN WE CAN'T HELP YOU QUICKLY  
What if someone in your home calls 911 for HELP!

**Fire Department, Police and an Ambulance will respond, but need your assistance to find you faster!**

What if:

- The *weather conditions are bad, and visibility is poor.*
- You have let bushes, vines or weeds grow to hide the numbers where your address is posted.
- You have placed your numbers too low on the post and they have been covered by weeds.
- You have placed brass address numbers on your post which do not contrast with the background color and cannot be easily seen.
- You placed address numbers in the mailbox, but numbers are covered when flag is pulled down.
- You have not posted your 911 number by your driveway or gate.
- Your address numbers on mailbox are small, obstructed and/or non-reflective.

**PLEASE TAKE A COUPLE OF MINUTES TO ENSURE YOUR ADDRESS NUMBERS ARE PROPERLY POSTED AT YOUR HOME!**

Imagine how and where emergency personnel would be looking to find your home. The **LARGER and BOLDER** your address numbers are, the quicker and easier it will result in you getting help. If you were driving an emergency vehicle, what would you be looking for to find a residence quickly?

Read the following 911 Standards and look at some examples that follow.

Should you need assistance or have questions, please do not hesitate to contact the Fire Station at 210-684-3219. Do not wait until there is an emergency.

911 Address Standards are listed below.

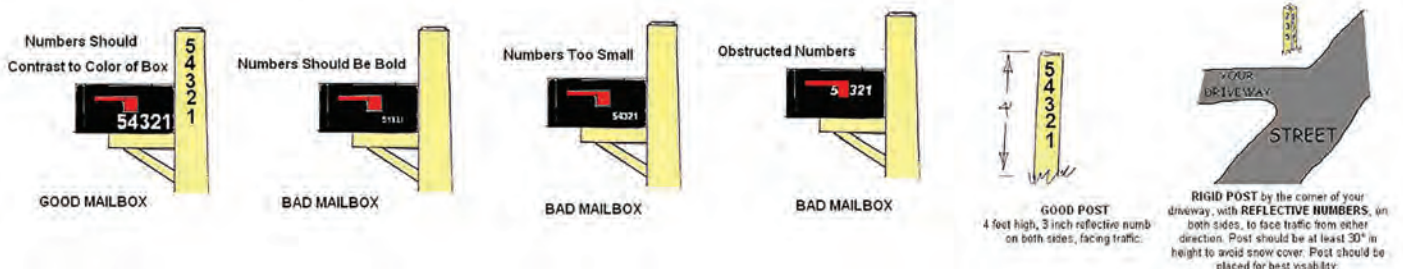
## Mailbox Address Number Placement:

Place mailbox post three feet from the edge of driveway and two feet from the edge of the roadway (same as mailbox). Post your 911 Mailbox Address Numbers on both sides of the box, facing traffic from either direction with **REFLECTIVE NUMBERS AND/OR CONTRASTING NUMBERS – SIZES ARE RECOMMENDED TO BE NO LESS THAN 3" INCHES HIGH (4" INCH NUMBERS ARE PREFERRED)**

## Address Post Placement:

If your mailbox is on the **OPPOSITE SIDE OF THE ROAD** from your property, you **NEED TO INSTALL A RIGID POST** by the corner of your driveway, with **REFLECTIVE AND/OR CONTRASTING ADDRESS NUMBERS**, on both sides, to face traffic from either direction. (3 Sides if more than two access directions exist or on a shared driveway. Post should be at least 48" inches in height to avoid obstruction by grass and weeds. Post should be placed for best visibility from ANY approaching (driving) direction.

# Code Violation Facts

## **What is considered an overgrown yard?**

To be considered “overgrown”, grass/ weeds must be taller than 12 inches. After it is reported, the Code Enforcement Officer will send notice to the owner to cut the grass. Once notified, the homeowner has 10 days to bring the yard into compliance.

*Sec. 6.03.005 - Notice to remove*

*(a) It shall be the duty of the authorized official of the city to notify the owner and/or agent of any premises within the city which are grown up in weeds to a greater height than 12 inches, or have accumulated debris, to remove such weeds or debris within ten days.*

## **Can my neighbor have a trailer, camper, or RV in their front yard?**

No, all vehicles must be parked on the driveway, in the garage, or under a carport.

*Chapter 12 Traffic and Vehicles, Sec. 12.03.052 - Parking in front or side yard*

*(a) No vehicle whatsoever shall be parked in the front yard or side yard of any property zoned R-1, R-2, R-4, or R-6, except in the driveway thereof, in a garage or in a carport. This section does not apply to vehicles when they are in the process of loading or unloading property or to street parking regulations as defined in other parts of this chapter or code.*

## **Can my neighbor park a broken-down vehicle in the street?**

No, all vehicles must be parked on a driveway, in a garage, or under a carport.

*Chapter 12 Traffic and Vehicles, Sec. 12.03.002 - Parking damaged or junked vehicle on street or right-of-way*

*No wrecked, damaged, junked or broken-down automobile vehicle of any kind shall ever be parked, placed or left in any street, alley, or public right-of-way within the city at any time.*

## **Can my neighbor park their vehicle, trailer, camper, or RV on the street for an extended period of time?**

No, vehicles must be moved every 48 hours and all trailers and/or campers must be attached to a vehicle to be legally considered parked in the street.

*Chapter 12 Traffic and Vehicles, Sec. 12.03.003 - Parking for longer than 48 hours; parking for certain purposes prohibited; parking of trailers or campers*

*It shall be unlawful for any person to park unused vehicles of any kind in any street or public place for more than 48 hours, or at any time for the purpose of storage, washing, greasing or repairing such vehicle (except repairs necessitated by emergency), sale, or display of advertising signs or posters fixed to such vehicle, or any trailer, semitrailer, horse trailer, or boat trailer not attached to a tractor or towing vehicle, or any auto-bus, motor home or camper.*

### **Can my neighbor block my driveway?**

No, vehicles are not allowed to impede ingress and egress to a public or private driveway.

*Chapter 12 Traffic and Vehicles, Sec. 12.03.004 - Blocking driveway*

*No automotive vehicle shall be parked in any manner which will block or impede free vehicular ingress and egress to all public and private driveways opening into any street, alley, or public right-of-way in the city.*

### **My neighbor has a lot of different people going and coming from their home; I think they have a business. Is this allowed?**

Individuals possess the freedom to invite guests to their residences as they see fit. However, if evidence indicates that the premises are designated for commercial activities, such as through a social media ad, specific regulations outlined in Chapter 15 Zoning, Sec. 15.02.315 - Home Occupations comes into play. These regulations dictate whether certain types of businesses are permissible within a residential setting. Mere hosting of numerous visitors does not automatically imply the residence is being utilized for commercial purposes.

### **My neighbor has visitors that come in junked vehicles. Is this allowed?**

Yes, individuals are permitted to welcome guests to their homes using any mode of transportation they prefer. The city does not regulate vehicle aesthetics or enhancements.

### **My neighbor has a junked vehicle - can the city tow the vehicle?**

Yes, if the vehicle meets the definition of a junk vehicle.

*Chapter 8 Offenses and Nuisances, Article 8.08, a junked vehicle is one that is wrecked, dismantled or partially dismantled, or discarded; or inoperable and has remained inoperable for more than 72 consecutive hours if the vehicle is on public property; or 30 consecutive days if the vehicle is on private property.*

### **What if the vehicle has an expired license plate?**

A motor vehicle that displays an expired license plate or does not display a license plate may be considered a junk vehicle if it meets the definition above.

### **How many animals can my neighbor have?**

The number of animals depends on the size of the lot you live on. For most residential homes, a maximum number of four cats or four dogs or any combination of up to four total cats and dogs, no more than two of which may be unsterilized. More information can be located under Chapter 2 Animals, Sec. 2.01.013 - Maximum number of animals in the city code [https://library.municode.com/tx/leon\\_valley/codes/code\\_of\\_ordinances](https://library.municode.com/tx/leon_valley/codes/code_of_ordinances)

*(a) In residential areas of the city with lot sizes of less than one acre, a household may keep, shelter, maintain or harbor up to:(1)A maximum number of four cats or four dogs*



or any combination up to four total cats and dogs, no more than two of which may be unsterilized.(2)A total of six animals of any combination of domestic dogs, cats, domestic fowl, snakes, rabbits, or any other approved animal in accordance with this Code and other applicable building and zoning regulations.

### **My neighbor leaves their pet outside 24/7. Is this allowed?**

Yes, at a minimum, an owner, keeper or temporary owner of an animal is required to provide their animals with humane care and treatment as follows: Access to an adequate supply of fresh air, species-specific food, fresh water, exercise, shelter (that provides the dog protection from inclement weather; and with dimensions that allow the dog while in the shelter to stand erect, sit, turn around, and lie down in a normal position), shade (natural or artificial), and veterinary care when needed to prevent suffering.

### **My neighbor ties up their pet. Is this allowed?**

Yes, if the tether is more than 10 feet or not causing injury.

Chapter 2 Animals, Sec. 2.01.002 - General regulations as to care, keeping and using of animals. No person may restrain a dog by a tether that:(A) Is less than ten feet in length or five times the length of the dog measured from nose to the base of the tail, whichever is longer; or(B) Due to the weight of the tether itself, causes injury or visible discomfort to the dog.

### **My neighbor's dog is barking constantly. Can something be done?**

Yes, an animal noise nuisance is defined as a minimum of ten minutes of noise events over a period of one hour where the animal can be heard continuously 100 yards away, or behind the wall of a livable structure

Chapter 2 Animals, Sec. 2.01.003 - Animal nuisances

The owner or keeper of any animal in the city is responsible for the behavior and conduct of that animal at all times including the creation of a public nuisance.

Violations of the following acts or omissions are public nuisances: The owner or keeper shall not allow animals being held on their property to create a noise disturbance in such a manner, to annoy, distress or disturb within the vicinity of hearing thereof. For the purpose of this chapter, an animal noise nuisance shall be defined as a minimum of ten minutes of noise events over a period of one hour where the animal can be heard continuously 100 yards away, or behind the wall of a livable structure;
