**Presentation, Discussion and Possible Action with a Record Vote on Proposed FY 2022-23 Tax Rate (M&C # 2022-08-21-4956 K. Rule)**

Crystal Caldera, City Manager and Kevin Rule, Finance Director were present to answer any questions or concerns that the City Council or members of the public had on the previously presented Proposed Budget for Fiscal Year 2022-2023.

Councilor Josh Stevens presented another option.

Those who spoke on this item were: Evan Bohl (Leon Valley)

Councilor Will Bradshaw motioned to call the question. The motion was seconded by Councilor Benny Martinez.

Councilor Josh Stevens called a Point of Order and was recognized by Mayor Chris Riley.

Councilor Stevens asked for clarification.

Councilor Will Bradshaw called a Point of Order and reminded the Mayor that the question has been called and seconded.

A motion was made by Councilor Will Bradshaw to adopt the No New Revenue Rate of 0.484739 for Fiscal Year 2022-2023. The motion was seconded by Councilor Jed Hefner.

Mayor Riley asked City Secretary Sandra Passailaigue to take a roll call vote.

City Secretary Passailaigue proceeded with a roll call vote to which the City Council replied: Councilor Benny Martinez - Nay; Councilor Josh Stevens - Nay; Councilor Jed Hefner - Aye; Councilor Rey Orozco - Nay; and Councilor Will Bradshaw - Aye.

Mayor Riley announced the motion failed.

City Secretary Passailaigue proceeded with a roll call vote to which the City Council replied: Councilor Benny Martinez - Aye; Councilor Josh Stevens - Aye; Councilor Jed Hefner - Nay; Councilor Rey Orozco - Aye; and Councilor Will Bradshaw - Nay.

Mayor Riley announced the motion carried.
