#### Greetings Council:

I am morally outraged that the city administrators continue their hostile opposition to the rightfully elected city council. Instead of diligently serving the public, the city manager and many department heads have chosen to fight the will of the people, wastefully hemorrhaging tax dollars along the way.

Important items that the city administration should have completed this month include:

- Issuance of a Certificate of Occupancy to the San Antonio Aquarium,
- Prompt release of open records that are subject to required public disclosure,
- Posting of the RFQ for city attorney legal services,
- Procedural and cultural reforms required to assist the public with stray animals,
- Thoughtful responses to council and citizen questions,
- And more.

Unfortunately, City Manager Perales prefers to launch a political attack against the council rather than seeing to the faithful execution of city business. Pursuant to the Home Rule Charter, Section 5.01(C)(8), "the city manager shall perform such other duties as... may be required by the city council."

On January 19th of this year, Councilor Hefner spoke about proposals to reform the city charter: [quote] "This is what's great about our country, we can have this debate, we can have conversations about how we desire to be governed. Bring any issue to the table that you want, let's discuss the issue, and let's leave attacks on individuals about even raising a question, let's leave those outside, because raising the question is our duly elected responsibly." [end quote]

Rather than have a conversation about the charter, Mr. Perales chose to quit. It is clear that Mr. Perales and Leon Valley are not a good fit. I encourage the council to allow Mr. Perales to leave town as quickly as he desires, preferably by the end of this week.

I won't speak for everyone, but at least my days were much less stressful during the time Dr. Caldera served as city manager.
