Presentation and Discussion on an Ordinance Authorizing a Budget Adjustment from the General Fund Reserve in the Amount \$1,246,101 to Complete the Funding of the Evers Road Bridge Project (1st Reading as Required by City Charter) (M&C # 2018-04-03-03 M. Moritz)

Interim Community Development Director Melinda Moritz presented this item for City Council consideration of an ordinance authorizing a budget adjustment from the General Fund Reserve, in the amount of \$1,246,101, to provide adequate funding for the Evers Road bridge project.

The Evers Road bridge project was partially funded in the spring of 2017. At that time, the total for construction, project administration, inspection, and materials testing costs were unknown, as the project had not been fully designed and advertised for bid, so \$1,287,750 was inserted into the budget as a placeholder. The project was bid and is now underway, but the bids came in above the placeholder amount, and it also includes work that will be reimbursed by CPS Energy.

The Federal Highway Administration (FHA) and the Texas Department of Transportation (TxDOT) will also be reimbursing the City as the project moves forward.

This ordinance will be presented at the next City Council meeting for the second reading,

as required by City Charter.

Discussion, Consideration and Possible Action to Dissolve the Mayor's Youth Advisory Council and Establish the Proposed Leon Valley Leadership Academy (M&C # 2018-04-03-04 A. Wayman)

Assistant Finance Director Ashley Wayman presented this item with a staff recommendation that the City Council move to dissolve the Mayor's Youth Advisory Council and approve the establishment of the Leon Valley Leadership Academy.

 Marianna Sanchez spoke about possibly inviting college students to be part of the academy.

A motion was made by Councilor Monica Alcocer and seconded by Councilor Belinda Ealy to adopt as presented with the amendment that the letter of recommendation be made optional verses a requirement.

Presentation and Discussion on an Ordinance Amending the Leon Valley Code of Ordinances to Add Article 4.10 Game Room Establishments (1st Reading as Required by City Charter) (M&C # 2018-04-03-05 J. Salvaggio)

LVPD Chief Joseph Salvaggio presented this item seeking City Council consideration of an amendment to the City of Leon Valley Code of Ordinance to: add Article 4.10 Game Room Establishment; provide definitions under the ordinance; set penalties for violations of the ordinance; create game room establishment regulations; provide permitting requirements; develop operation regulations; and to amend appendix a fee schedule.

Chief Salvaggio concluded the presentation saying that the City Manager and he request feedback on adding the changes to the Leon Valley Code of Ordinances as detailed in this Presentation.

Mayor Riley asked if this proposed amendment had gone through the Citizens Police Advisory Committee to which Chief Salvaggio responded that it is on the April 11, 2018 Citizens Police Advisory Committee Agenda for discussion.

This ordinance will be presented at the next City Council meeting for the second reading,

as required by City Charter.

Presentation and Discussion on an Ordinance Authorizing the Expenditure of Economic & Community Development Funds in the Amount of \$32,500 to Provide Funding for the Leon Valley 2018 July 4th event; and Authorizing a Budget Adjustment in the Amount of \$32,500. (1st Reading as Required by City Charter) (M&C # 2018-04-03-06 S. Passailaigue)

City Secretary Saundra Passailaigue presented this item for City Council consideration to authorize the acceptance of an Economic & Community Development sponsorship and to authorize a budget adjustment in the amount of \$32,500, by decreasing the Economic and Community Development Project Funding line item and increasing the July 4th Event line item

Ms. Passailaigue added that a presentation was made to the Leon Valley Economic & Community Development Advisory Committee seeking sponsorship of the Leon Valley 2018 July 4th Event. At that meeting a motion was made to expend \$32,500 as long as some of the amount was specifically appropriated toward a "military appreciation" expenditure to keep with this year's July 4th theme of "Land, Sea, and Air…Leon Valley is Everywhere!" The motion passed unanimously.

- John Stanley asked for the justification to expend Economic and Community Development funds for this event.
 - Ocity Manager Kelly Kuenstler said that it is justified by the large amount of visitors the City of Leon Valley has during this event and that these visitors come and go through Leon Valley and spend money here. This event also showcases Leon Valley to those visitors.

Councilor Belinda Ealy and Council Member Benny Martinez added that it helps the community recognize that the City of Leon Valley is a viable entity.

This ordinance will be presented at the next City Council meeting for the second reading, as required by City Charter.
