City Manager Kelly Kuenstler presented this item seeking City Council consideration of a budget adjustment in the amount of \$20,000 to fund an internal investigation regarding safety and administrative policies in the Fire Department.

ORDINANCE No.

AN ORDINANCE OF THE CITY OF LEON VALLEY, TX., CITY COUNCIL AMENDING THE GENERAL FUND OF THE CITY OF LEON VALLEY, TEXAS MUNICIPAL BUDGET FOR FISCAL YEAR OF 2017-2018 IN THE AMOUNT OF \$20,000 TO PROVIDE PROPER FUNDING FOR THE GENERAL FUND; PROVIDING FOR REPEALER, SEVERABILITY AND SAVINGS CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The City of Leon Valley passed their FY2017-2018 Budget on August 15, 2017; and

WHEREAS, City Council approved the budget for the General Fund for FY2017-2018; and

WHEREAS, staff has determined that funding should be added to the FY2017-2018 General Fund Budget; and

WHEREAS, it is necessary to adjust the General Fund Budget by \$20,000 for FY2017-FY2018; and

WHEREAS, Texas Local Government Code Section 102.010 provides that a municipality is not prohibited from making changes to a budget for municipal purposes: and

WHEREAS, the Leon Valley City Council hereby finds and determines that the amendments adopted under this ordinance are for a municipal purpose;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEON VALLEY, TEXAS, THAT:

SECTION 1. The FY 2017-2018 General Fund of the City of Leon Valley is hereby amended to increase the budget by the amount of \$20,000. The funds for the increase will come from General Fund Reserves.

.**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations as necessary to carry out the purpose of this Ordinance.

SECTION 4. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable,

and if any phrase, clause, sentence, or section of this Ordinance shall be declared unconstitutional or invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any other remaining phrase, clause, sentence, paragraph or section of this Ordinance.

SECTION 5. The repeal of any Ordinance or part of Ordinances effectuated by the enactment of this Ordinance shall not be construed as abandoning any action now pending under or by virtue of such Ordinance or as discontinuing, abating, modifying or altering any penalty accruing or to accrue, or as affecting any rights of the municipality under any section or provisions at the time of passage of this Ordinance.

SECTION 6. This Ordinance shall become effective immediately upon its passage and publication as required by law.

2018, Board of Adjustment Appointments and Consider Re-Appointments

PURPOSE

The purpose of this item is to present to City Council all applications for the Board of Adjustment. The following errors occurred with the June 19, 2018 appointments based on clerical errors in the material that was presented. There was one application (Lyn Joseph) unintentionally left off of the list; and two names (David Smith and Geraldine Rodriguez-Smith) on the list but they did not actually apply for the BOA.

On April 20, 2018, an email was sent to all boards/commissions/committee members who, by the Leon Valley Code of Ordinances, had terms coterminous with the term of the Mayor. These terms would expire May 31, 2018. The email included the Volunteer Application and a deadline to submit of no later than May 7, 2018.

On April 27, 2018, another email was sent to liaisons with an update indicating how many of the committee members had actually submitted their applications since the original email from April 20th was sent out.

On May 01, 2018, another email was sent to all liaisons and board/commission/committee chairs. This email was to inform the chairs that the City Council had extended the expiring terms from 5/31/18 to 6/30/18 due to an amendment to the process via Ordinance No. 2018-37.

With City Council's adoption of Ordinance No. 2018-37 the following amendment was made:

SECTION 1. An amendment adding the following language to the Leon Valley Code of Ordinances Chapter 1 General Provisions, Article 1.06 Boards, Commissions, and Committees, is hereby authorized:

"Section 1.06.006 Board Appointments and Succession.

- (a) All members and alternates shall be appointed by City Council through resolution.
- (b) For boards and commissions that have alternates, if a member position becomes vacant, the Chairman of that board, committee, or commission may ask the first alternate if he or she wishes to become a regular member. If the alternate consents to the appointment in writing, the board, committee, or commission shall vote to approve such recommendation and submit that recommendation to the City Council that such alternate be appointed as a regular member and forward the written consent of the alternate. Should the first alternate position be vacant or the alternate does not consent in writing, the Chairman of that board, committee, or commission may ask the second alternate, vote, and then forward such recommendation and written consent to the City Council for appointment, and so on until a recommendation and written consent is presented to City Council. Should alternate positions be vacant or the alternates do not consent to the consideration of appointment, the City Council may consider other candidates for the member position, when all alternates considered for recommendation have been exhausted."

On May 25, 2018 another email was sent to each of the boards/commissions/committee chairs (individually) with a scanned copy of all applications submitted for their particular board/commission/committee. In that email, the chair was asked to forward their recommendation to City Council to the City Secretary no later than Wednesday, June 13th so it could be placed in the City Council packet for consideration. Each liaison was included with their appropriate board/commission/committee.
