B) asked for a consensus from City Council on whether or not they wanted their email addresses put back on the website (there was a consensus to do just that); C) Ambulance services uncompensated care cost settlement amount - the City is getting a settlement amount of \$33,830.99 by October 1st. This amount could change but if it does it is believed that it will only be to the good. D) Sales tax is up 5.53% in September. E) The City of Leon Valley received the Certificate of Achievement for Excellence in financial reporting by GFOAT for its annual CAFR. F) Councilor Monica Alcocer wanted Tobacco 21 topic on the October Coffee with the Mayor & City Council agenda. City Manager Kuenstler asked for a consensus to add it to the agenda (there was a consensus to add it). G) We received notice from Bexar County that Leon Valley has been preliminarily awarded another CDBG Grant for the Blacksmith & Water Spoke Water & Sewer Main Replacements in the amount \$302,632 which is half of the funding needed for the

project which came to about \$605,000.00. H) Gave a report on which streets Tiger Sanitation had completed brush pick up on so far. I) Culinary Flavors of Leon Valley will be held September 5th from 9:00 a.m. to 10:00 a.m. in the Public Library parking lot. Discuss and Consider Possible Action on an In Kind Grant Request by the Leon Valley Historical Society for Use of the Leon Valley Community Center at 6427 Evers Road for the Pioneer Gala (M&C # 2018-09-18-08 M. Mendoza)

Special Events Coordinator Maribel Mendoza presented the item in response to a request that was submitted by the Leon Valley Historical Society is requesting in kind grant for use of the Leon Valley Community Center on Friday, October 19, 2018, for their Pioneer Fundraising Gala. The request is for the use of the facility, to include waiver of rental fees and assistance with setup and take down of the event. The Leon Valley Historical Society is willing to pay for the deposit, clean-up set-up and security fees.

The set-up of the Center will be during the hours of 2:00 p.m. - 5:00 p.m. on Friday. The event will begin in the evening from 6:30 p.m. -10:30 p.m. The purpose of the event is to fundraise for the Huebner- Onion Homestead and Stagecoach Stop Restoration Project. No alcohol will be sold. In reviewing the Community Center calendar and the City resources, the date and facility is available for use.

The In Kind Grant Committee consists of representation from Community Development, the Leon Valley Library, and the administration departments.

The In Kind Grant Committee evaluated the request based on the criteria outlined in the grant policy and guidelines. A scoring matrix was created to further evaluate the request. Per the matrix the maximum score is 24. In evaluating the request, a score of 18 or above results in an affirmative recommendation by the committee members, to then forward to Council for final consideration.

The attached request scored a median average of 19.25 resulting in a recommendation of approval to be forwarded to the City Council for final consideration.
