## OCTOBER 19TH CITY COUNCIL MEETING

Brief highlights of the City Council action from this meeting are:

- Rezoning Request (First Reading) from R-1 and B-2 to B-2 District with no Sustainability Overlay (SO) from St. John's Church at Huebner & Evers Road. In the middle of the discussion, the Church amended their request to add 500 feet to the existing B-2 on the front of the property, keep the remaining land as R-1 and withdraw the request to remove the SO. A ruling by the City Attorney is pending to determine if the amended request will need to be referred back to the Planning & Zoning Commission with additional public notice due to the requested amendment. As of 10/22/2021, a ruling had not been made.
- Council voted to establish a dog park on land the City owns along Salazar Road across from the NW Little League. Councilor Stevens communicated with Google Fiber in seeking their monetary support for the dog park as it relates to Google Fiber leasing property on the dog park property to build their "hut". This leasing issue and funding source from Google will be brought back at a future meeting.
- Council heard the request from City Manager Perales to authorize additional spending of \$316,000 from the American Rescue Plan (ARP) for the following: A one-time bonus (\$150,000) to our dedicated essential employees for their work during COVID; set aside \$50,000 for citizen utility assistance arising from COVID; \$10,000 reimbursement for air conditioning repair in the police department; \$41,000 to upgrade the council chamber audio visual equipment; \$40,000 to purchase new agenda software (Municode) focused on website update and processing Freedom of Information Act requests; and \$25,000 reimbursement for library AC repairs. The ARP fund balance after these expenditures will be \$857,206.95. This will be voted on at the November 2<sup>nd</sup> meeting.

## "TWO DOSES OF VACCINE & ONE DOSE OF HUMILITY"

The quoted words were from Dr. Anita Kurian's message to the Suburban Mayors this week at our quarterly meeting with Judge Nelson Wolff. Although the COVID-19 numbers are the best we have seen in months – daily hospitalizations under 300, positivity rate fell from 3% to 2.1% - she emphasized that this virus is very unpredictable and is not over until we get a higher percentage of people vaccinated. Currently in Bexar County, the total population which is fully vaccinated stands at 63.1%. The percentage of the population which needs to be fully vaccinated to develop "herd immunity" is between 75-90%, so we still have a challenge facing our community. There are 90,000 20 year- olds who are eligible to be vaccinated. If you are fully vaccinated and are under 65 and would like to receive the booster, Bill Phillips from University Hospital reports that anyone 18 years or older can receive the Pfizer booster after proving 6 months have lapsed since your second dose. Vaccinations are readily available.

If you are homebound and would like the vaccine, call 844-908-3927,

Option 1 to request a state mobile vaccination team to come to your house.

Choose Option 3 if you have a business or group consisting of 5 or more

who wants to receive the vaccination and the mobile unit will schedule a visit.

It is anticipated beginning on November 3<sup>rd</sup>, children ages 5-11 will be able to register through University Hospital to receive a vaccination which will be administered at Wonderland Mall. Hours are 10am – 6 pm, Monday-Friday. Consent by their parent or guardian is needed. Call (210) 358-4000 for more information.

Our community has had three waves of COVID-19 increases in cases and deaths since March, 2020: May- August, 2020, November, 2020 to March, 2021 and July, 2021 – September, 2021. Let's continue doing our part to bring and keep the COVID numbers down. CDC and Metro Health both report a possible 4<sup>th</sup> wave may be coming this winter, so let's stay vigilant.
